## ICCT in a Snapshot

### 1. Total staff and ICCT affiliates in 2021

In 2021, ICCT counted 18 staff members and 14 interns in total. We also maintained a community of 64 ICCT Associate/Research and Visiting Fellows and 36 Editorial Board members. These are leading scholars and/or practitioners contributing to our thematic approaches to countering terrorism.



### 3. ICCT Global Impact in 2021

ICCT has managed to maintain a worldwide impact throughout 2021, in spite of the challenges posed by the global pandemic of Covid-19. Specifically, we have provided 3 workshops on rule of law based administrative measures in a counter-terrorism context for 23 countries (in sub-Saharan Africa, MENA and South- Southeast Asia); held trainings and collected data for a USAID-funded project on the role of traditional authorities in enhancing resilience to violent extremism in the Sahel; and worked on both the management of violent extremist offenders and youth resilience in Mali. In Europe, we offered trainings and advice to policy-makers and practitioners from EU countries through the Radicalisation Awareness Network (RAN).


## 7. ICCT Events

### 6.2 Project Summaries

- RAN:** Our RAN efforts are a continuation of ICCT's involvement in the Radicalisation Awareness Network. This project encourages a better sharing of ideas that will improve contact between thousands of first-line practitioners, numerous law enforcement agencies and various national administrations. The RAN project is an "umbrella network", or network of networks and provides a platform for practitioners to gather and share best practices in countering radicalisation leading to violent extremism. It touches upon multiple sensitive topics such as the spread of violent extremist ideologies online and offline, polarisation in local communities, management of [foreign terrorist fighters](#) and their families, radicalisation in prisons and the rehabilitation of ex-offenders. ICCT's involvement is dedicated towards directly supporting EU Member States and the Commission in countering violent radicalisation by ensuring that the Commission is equipped with the best academic knowledge of extremism, as well as dedicated tools and support towards strategic communication.
- SALW:** Proliferation, illicit trafficking, and diversion of small arms and light weapons (SALW) across the world poses a significant threat to peace and security at a national, regional, and global level. The illicit flow of SALW has a destabilising effect on societal advancement, economic growth, sustainable development, and human rights. When illicit trafficking and diversion of SALW occurs within the context of an armed conflict – whether this is during a civil war or intercommunal, interstate, or internal conflict – in which terrorist organisations operate, this further fuels the conflict and poses significant challenges to security and conflict prevention. The flow of illicit SALW can increase the intensity and duration of conflicts and has deteriorated the security situation. Together with Project CRAFT, ICCT has conducted this research project about Small Arms and Light Weapons.

3. **GNET:** The Global Network on Extremism and Technology (GNET) is an academic research initiative backed by the Global Internet Forum to Counter Terrorism (GIFCT), an independent but industry-funded initiative for better understanding, and counteracting, terrorist use of technology. ICCT's broad network of experts have enabled valuable additions to the project.
4. **USAID:** The border regions of countries such as Mali, Niger, and Burkina Faso are far out of reach of these states' central governments. Violent extremist organisations (VEOs) in West Africa have been able to capitalise on the resulting widespread feelings of deprivation, marginalisation, social injustice, and a lack of economic opportunities. In the process, they have come into direct contact with traditional local governance providers, such as tribal chiefs and imams, who have historically taken on key governance tasks in these remote regions. This research project seeks to further the understanding of the role of TAs in strengthening and/or weakening community resilience to violent extremism in the Sahel. Towards this end, it asks the central research question: Do traditional authorities contribute to or weaken resilience against radicalization towards violent extremism in VEO-affected areas, and if so, in what manner.
5. **Mitigating the Impact of Media Reporting of Terrorism:** This project aims to produce evidence-based guidance and capacity building outputs based on original, context-sensitive research into the risks and opportunities in media reporting of terrorism and terrorist incidents. The role of media reporting on terrorism has been under investigated and is an underutilised dimension of a holistic counter-terrorism strategy. How the media reports on terrorism has the potential to impact counter-terrorism (CT) perspective positively or negatively.
6. **Criminal Justice Responses to the Linkages between Terrorism and International Crimes:** The Linkages between Terrorism and International Crimes Project is spearheaded by ICCT and is being conducted in association with the Global Counter Terrorism Forum's Criminal Justice and Rule of Law Working Group. The main objectives were: Increasing the understanding of the nexus between terrorism, sexual and gender-based violence, human trafficking, migrant smuggling and international crimes; Strengthening the (international and national) legislative framework and its implementation; Overcoming the jurisdiction challenges related to the linkages between terrorism, sexual and gender-based violence, human trafficking, migrant smuggling and international crimes; Enhancing the investigation and prosecution of terrorist-related crimes with linkages to sexual and gender-based violence, human trafficking, migrant smuggling and international crimes; Strengthening the position of victims.
7. **Rule of Law Based Use of Administrative Measures in a Counter-Terrorism Context:** The training and Policy Kit Project ran from November 2019 to December 2021. It was spearheaded by ICCT and conducted in association with the Global Counter Terrorism

Forum's Criminal Justice and Rule of Law Working Group and the International Institute for Justice and the Rule of Law. The aim of the project was to improve a Rule-of-Law based use of administrative measures in a CT context. The Training and Policy Kit and the subsequent workshops were designed to further support practitioners, policymakers as well as other governmental experts, to formulate responses and to translate the GCTF's Glion recommendations into concrete actions.

8. **MERIT: Countering Violent Extremism in Mali:** Since 2016, ICCT has been developing and implementing activities in Mali to prevent and counter violent extremism in prisons and local communities. We have focused on improving the management of Violent Extremist Offenders (VEOs) in prison and on increasing the resilience of Malian youth and their communities against violent extremism. Young people play a key role, as they represent a majority of the Malian population (almost 70% are 24 years or younger) and therefore the future of the country. Their engagement in promoting alternatives to violence is therefore crucial for any counter-terrorism initiative to succeed. The activities have been conducted in collaboration with local, national and international actors including MINUSMA, the Malian Prison Administration, the Ministry of Religious Affairs, and civil society organisations and in partnership with various members of the international community, such as the Royal Danish Embassy in Bamako and the US Bureau of Counterterrorism. The [first](#) and [second](#) concluding reports present important project findings.
