Tanya Mehra is a Senior Research Fellow and Programme Lead (Rule of Law Responses to Terrorism) at the International Centre for Counter-Terrorism (ICCT). Her main areas of interest are international (criminal) law and rule of law approaches in countering terrorism, with a focus on bringing alleged terrorists to justice for the full range of crimes they have committed, in full compliance with human rights. This includes researching prosecutorial strategies, collecting information from the conflict zone and the use of administrative measures in a counter-terrorism context. Tanya also worked as a senior consultant to United Nations Counter-Terrorism Executive Directorate (UNCTED) in developing global guidelines to facilitate the

collection of information and evidence by military and other relevant criminal law actors within a rule-of-law framework and is - together with GCTF Criminal Justice and Rule of Law (CJ-ROL) Working Group Co-Chairs Nigeria and Switzerland – responsible for developing the Abuja Recommendations, the Glion Recommendations, and the Interlinkages Memorandum.

Thomas Renard is the Director of the International Centre for Counter-Terrorism (ICCT). His research focuses on (counter-) terrorism and (counter-) radicalisation in Europe. His recent research has focused on the evolution of counter-terrorism policy, on (returning) foreign fighters, on radicalisation in prison and on terrorist recidivism. His latest book is *The Evolution of Counter-Terrorism since 9/11* (Routledge, September 2021).
